Roles and Responsibilities:

1. The committee shall be responsible for observance of all standing financial and other rules and procedure, provisions of AFRBM Act, 2005 and extant guidelines and shall be accountable to the District Authority and subject to Audit by AG.

On completion of work, the implementing agency shall quickly finalize the accounts for the work and shall furnished a work completion report, utilization certificate, MB, mR, photographs (before/ during/ after) etc. to the Deputy Commissioner, Kamrup(M) within the stipulated time frame.

3. The lands belonging to Trust, Tea Garden areas, religious and many other institutions etc. the Construction Committee has to take No Objection Certificate from the concerned authority before execution of scheme.

4. In pursuance of the T&D Deptt. letter no. PD/DCP/62/2016/160, DTD. 27/08/2018, it is mandatory for the Construction Committees to procure materials from active registered taxpayers under GST Act, the office bearers of the committee shall be personally liable to pay GST @ 12% of the materials value.

5. The committee has to purchase the material for implementation of the scheme through Cheque or by DST, not
